

शिवसेना के प्रतिद्वंद्वी गुटों ने एक दूसरे पर निशाना साधा

मुंबई, एजेंसी। महाराष्ट्र के मुख्यमंत्री एकनाथ शिंदे के नेतृत्व वाली शिवसेना के विधायकों ने बृहस्पतिवार को यहां विधान भवन की सीढ़ियों पर पूर्व मंत्री आदित्य ठाकरे के खिलाफ बैनर दिखाते हुए उन पर निशाना साधा। आदित्य ठाकरे ने उनके जवाब में नारा लगाया जिसका मतलब था कि शिंदे खेमों के विधायकों को धन देकर पाला बदलवाया गया जिसकी वजह से उद्धव ठाकरे नीत सरकार गिर गयी। शिंदे गुट के विधायकों के हाथों में बैनर थे जिन पर लिखा था, 'बुधवार रातना भटके'। इन दिनों राज्य विधानसभा का सत्र चल रहा है। विधायक भरत गोपालवे ने

संवाददाताओं से कहा कि अगर शिंदे गुट के विधायकों को बार-बार निशाना बनाया जाता है तो वे हाथ बांधकर नहीं बैठने वाले। उन्होंने कहा, हम जवाब देंगे। दूसरी तरफ आदित्य ठाकरे और कांग्रेस तथा राष्ट्रवादी कांग्रेस पार्टी के कुछ विधायकों ने नारे लगाते हुए कहा कि महाराष्ट्र में वर्षों से फसलों को हुई तबाही को देखते हुए 'वर्षा जनि सुखा' घोषित किया जाए और बाढ़ के कारण फसलों का नुकसान उठाने वाले किसानों को राहत दी जाए। आदित्य ठाकरे को नारे लगाते भी देखा गया कि 50 विधायकों को उनके पिता उद्धव ठाकरे की अगुवाई वाली शिवसेना के खिलाफ विद्रोह के लिए धन मिला।

मोहन भागवत आज से त्रिपुरा के दो दिवसीय दौरे पर

अमरतला, एजेंसी। राष्ट्रीय स्वयंसेवक संघ (आरएसएस) के प्रमुख मोहन भागवत दो दिवसीय दौरे पर शुक्रवार को त्रिपुरा आएंगे। इस दौरान वह यहां उच्चतम महल जाएंगे और गोमती जिले के सरबोबा आश्रम में एक मंदिर का उद्घाटन करेंगे। पुलिस के एक वरिष्ठ अधिकारी ने यह जानकारी दी। उन्होंने बताया कि भागवत शुक्रवार तड़के एमबीवी हवाई अड्डा पहुंचेंगे और फिर वहां से उच्चतम महल के लिए रवाना होंगे। भागवत को 'जेड प्लस' श्रेणी की सुरक्षा मिली हुई है। माणिक्य राजवंश के महल में कुछ देर रुकने के बाद, वह पश्चिम त्रिपुरा जिले के खेरपुर इलाके में स्थित आरएसएस मुख्यालय 'सेवाधाम' जाएंगे। अधिकारी ने कहा, सेवाधाम से आरएसएस प्रमुख शनिवार को गोमती जिले के अमरपुर अनुमंडल स्थित सरबोबा आश्रम के लिए रवाना होंगे, जहां वह शांतिवादी आश्रम प्राधिकरण द्वारा नवीनिर्मित मंदिर का उद्घाटन करेंगे। भागवत शनिवार को अपनी रवानगी से पहले सरबोबा आश्रम में एक सभा को भी संबोधित करेंगे। अधिकारी ने बताया कि भागवत के दौरे के मद्देनायत राज्य में सुरक्षा के व्यापक प्रबंध किए गए हैं।

नई दिल्ली, एजेंसी। जाने माने लेखक सलमान रुश्दी पर हुए हमले के मामले में पहली बार प्रतिक्रिया व्यक्त करते हुए भारत ने बृहस्पतिवार को इस 'भयावह हमले' की निंदा करते हुए रुश्दी के जल्द स्वस्थ होने की कामना की। ज्ञात हो कि पश्चिमी न्यूयॉर्क के चोटाउका संस्थान में 12 अगस्त को एक कार्यक्रम के दौरान अपना व्याख्यान शुरू करने जा रहे सलमान रुश्दी पर एक शख्स ने मंच पर चढ़ कर, उनके गले पर चाकू से वार किया था। विदेश मंत्रालय के प्रवक्ता अरिंदम बागचो ने सप्ताहिक प्रेस वार्ता में कहा, भारत हमेशा से हिंसा और कट्टरपंथ के खिलाफ रहा है।

लोक सेवक सबसे वंचित लोगों तक पहुंचें: राष्ट्रपति

नई दिल्ली, एजेंसी। राष्ट्रपति द्रौपदी मुर्मू ने बृहस्पतिवार को कहा कि कोई भी कल्याण योजना तभी सही अर्थ में सफल मानी जा सकती है जब उसका लाभ गरीबों एवं समाज के सबसे निचले तबके के लोगों को प्राप्त हो। उन्होंने कहा कि ऐसे में लोक सेवकों से अपेक्षा की जाती है कि वे अपनी जिम्मेदारी वाले इलाके में सबसे वंचित लोगों तक पहुंचें और उनके जीवनस्तर को बेहतर बनाएं। वर्ष 2020 वैश्व के भारतीय प्रशासनिक सेवा (आईएसएस) के 75 अधिकारियों ने बृहस्पतिवार को राष्ट्रपति भवन में राष्ट्रपति द्रौपदी मुर्मू से भेंट की। ये अधिकारी अभी विभिन्न केंद्रीय मंत्रालयों एवं विभागों में सहायक सचिव के रूप में कार्यरत हैं। राष्ट्रपति भवन के बयान के अनुसार, राष्ट्रपति मुर्मू ने इन अधिकारियों को संबोधित करते हुए कहा कि लोक सेवक के रूप में उन्हें वैश्विक ज्ञान केंद्र, आपूर्ति श्रृंखला, नवाचार, प्रौद्योगिकी विकास सहित विविध क्षेत्रों में भारत को आगे बढ़ाने में महत्वपूर्ण भूमिका निभानी है।

केंद्रीय अन्वेषण ब्यूरो (सीबीआई) ने नौ लाख रुपये की रिश्वतखोरी के एक मामले में, केंद्रीय औषधि मानक नियंत्रण संस्थान (सीडीएसीओ) के एक संयुक्त औषधि नियंत्रक और बायोकाॅन बायोलॉजिक्स के बायोकाॅन बायोलॉजिक्स के एक कार्यकारी समेत पांच व्यक्तियों के विरुद्ध आरोपपत्र दाखिल किया है। अधिकारियों ने बृहस्पतिवार को यह जानकारी दी।


दिया। अधिकारियों ने बताया कि 21 अगस्त को राजौरी जिले में नौशेरा के शंगर सेक्टर में तैनात सैनिकों ने (नियंत्रण रेखा के दक्षिण और भारतीय क्षेत्र) में दो से तीन आतंकवादियों की गतिविधियां देखीं और उन्हें चुनौती दी। अधिकारियों ने बताया कि एक आतंकवादी ने भागने की कोशिश की लेकिन सैनिकों की गोलीबारी में वह घायल हो गया तथा उसे ज़िंदा पकड़ हमलावरों को सैनिकों ने मार गिराया।

आतंकी भागने में सफल रहे थे। वहीं, 22-23 अगस्त को रात दो से तीन आतंकवादियों के एक समूह ने नौशेरा के लाम सेक्टर में घुसपैठ की कोशिश की। लेकिन वारूदी सुरंगों में विस्फोट होने पर दो आतंकी मौके पर ही मारे गये। आतंकवादियों ने 11 अगस्त को राजौरी जिले में थल सेना के एक विधिवर पर हमला किया जिसमें चार सैनिक शहीद हो गये। हालांकि, दोनों हमलावरों को सैनिकों ने मार गिराया।

Illegal slaughtering: MCD issues notice to 449 shops

The MCD, taking action against illegal meat vendors, has issued notice to 449 shops and fined 470 shops from 1st April 2022 to 31st July 2022.

Persons involved in illegal slaughtering and selling of live chickens, fish etc. upon have been penalised and composite fee of Rs. 72,40,529/- has been levied upon them.

The MCD also forwarded a list of 146 persons involved in illegal slaughtering to the Delhi Police for registering FIR against them.

The veterinary department of the MCD took action against stray cattle and illegal dairies. The MCD fined 214 dairies and removed/sealed 34 dairies.

Similarly, in order to provide relief from menace of stray cattle, the MCD impounded 4,999 stray cattle and impounded them to Gashala.

As many as 27,919 monkeys were also caught during the period from 1st April 2022 to 31st July 2022 and released to Aśoka Bhilai mines Sanctuary.

The MCD's veterinary department sterilised and vaccinated 2,294 stray dogs with anti-rabies vaccine during the period from 1st April 2022 to 31st July 2022.

MCD installs rainwater harvesting system in 150 parks

The MCD claims to have installed rainwater harvesting system in 150 parks using defunct tube wells. It has identified 258 parks for the installation of rainwater harvesting system and a budget of Rs 41 lakh has been allocated for the same.

However, with equipping 150 parks with the rainwater harvesting system, the MCD said that the installation of the rainwater harvesting system in remaining 108 parks is expected to be completed in two weeks.

The MCD is committed to working for the public interest by making maximum use of its available resources. The rain water harvesting systems have been installed in the parks with use of defunct tube wells, at an expense of only Rs 15,000/- per system.

Water crisis is a global problem for which integrated efforts are required at all levels with responsibility and dedication. Indiscriminate exploitation of ground water has resulted in depleting ground water level and causing severe water crisis.

There are many scientific methods for this but the most effective way is rainwater harvesting, where rainwater is collected and managed properly.

The rainwater harvesting is the only option to overcome the water crisis. Working in this direction, the MCD has installed the rainwater harvesting system in its parks so that it can contribute towards resolving this problem to some extent.

Delhi Assembly's special session on Friday is likely to be stormy affair
