Kamala Harris Launches Presidential Campaign with Tim Walz as Running

He said, "The world is silent over this barbarism. Such terrorism and extremism are highly condemnable."

WASHINGTON: In a stirring announcement, US Vice President Kamala Harris declared her presidential campaign is not merely a contest against former President Donald Trump, but a crucial battle for America's future, according to CNN. Harris emphasized key issues including affordable housing, childcare, and healthcare in her address. Speaking at her first rally alongside running mate Minnesota Governor Tim Walz in Philadelphia, Harris stated, "This campaign, our campaign, it's not just a fight against Donald Trump. It's a fight for the future." Walz, standing firmly by her side, echoed her sentiments and bolstered her message.



SPEAKING AT HER FIRST RALLY ALONGSIDE RUNNING MATE MINNESOTA GOVERNOR TIM WALZ IN PHILADELPHIA, HARRIS STATED, "THIS CAMPAIGN, OUR CAMPAIGN, IT'S NOT JUST A FIGHT AGAINST DONALD TRUMP. IT'S A FIGHT FOR THE FUTURE." WALZ, STANDING FIRMLY BY HER SIDE, ECHOED HER SENTIMENTS AND BOLSTERED HER MESSAGE.

At the rally, Harris also shed light on her choice of Walz as her vice-presidential candidate, describing him as the ideal partner to help build an equitable future. She acknowledged the Democratic Party as underdogs but asserted they possess strong momentum going into the general election. Pennsylvania Governor Josh Shapiro and Harris' running mate, Walz, pledged to secure a victory for the Democratic Party in November. Later, Harris proudly announced her official nomination as the Democratic candidate for president, marking a historic moment as the first woman of color and first Asian American to lead a major party ticket. Reflecting on her journey from California and Walz's Nebraska roots, Harris expressed a unified vision for the nation, aiming to uplift all Americans. CNN's John King previously said that Harris may have selected Walz as her running mate due to their "comfort level," among other factors, and also because she thinks Walz would be a "good governing partner." "We're in such uncharted territory

with a campaign this late, with Donald Trump's vice presidential pick having a more of a rocky rollout. And so if you've watched, Gov. Walz has impressed everybody," King said. "This is a gift to Trump! On Harris' above X post, users slammed her for her choice. "You just picked the most far-left radical possible! Thanks! You just made it even easier for us to beat you. Walz is a gold mine of headlines and talking points for us," one user wrote. "This is a gift to Trump! THANK YOU," one user joked, while another said, "You just handed Donald Trump the election. Thanks, Silver Throat!" "Congrats on picking the most radical ticket in history!" one user said, while another wrote, "This might be the most radical left ticket in American history."

Bangladesh in Turmoil: Police Urged to Resume Duties Amid Crisis

DHAKA: Atop police official in Bangladesh has urged every member of the police force to gradually resume their duties and maintain public safety amidst escalating violence and attacks on law enforcement authorities in the nation. Additional Inspector General of Police A.K.M. Shahidur Rahman, appointed as the focal person of the Bangladesh Police to manage the current crisis, emphasized the crucial role of the police in society and asked his force to ignore rumours. "The police are friends of the people and work for the public. We cannot imagine a society without the police." Therefore, I request our police members once again to ignore rumours and return to their duties in a phased manner, ensuring that security arrangements are properly in place, Rahman stated.

Reports indicate that most police stations, including those in the capital Dhaka, are currently deserted. Over four hundred police stations have been subjected to attacks, vandalism, arson, and looting. Consequently, police officers have vacated their posts, seeking safer shelters. According to a police headquarters official, the force has not faced such a crisis since 1971. Clashes with agitated mobs

and the subsequent evacuation of law enforcement officers have exacerbated the situation. Following the attack on the police headquarters on Monday night, senior officials were evacuated to safety. The breakdown in law enforcement ties directly to the fall of the Sheikh Hasina government, leaving the country without adequate police presence. With the army now in charge following Hasina's ouster and the death toll rising to 440, President Mohammed Shahabuddin dissolved Parliament and appointed Nobel laureate Mohammad Yunus to lead an interim government. Meanwhile, the readymade garment (RMG) and textile factories are set to reopen. The Bangladesh Garment Manufacturers and Exporters Association (BGMEA) and the Bangladesh Knitwear Manufacturers and Export.

Donald Trump wants Joe Biden back in the race, says, 'What if he crashes DNC to take back nomination'

WASHINGTON: Former President Donald Trump recently took to his social media platform, Truth Social, to rant about President Joe Biden potentially crashing the Democratic National Convention to "take back nomination" from Vice President Kamala Harris and challenging him to "another debate." This comes after Biden, following a disappointing and shaky debate performance and mounting pressure from the Democratic Party, announced over two weeks ago that he would not be running in the 2024 presidential election. Biden endorsed Harris, stating, "Today I want to offer my full support and endorsement for Kamala to be the nominee of our party this

On Tuesday's post, Trump wrote, "What are the chances that Crooked Joe Biden, the WORST President in the history of the U.S., whose Presidency was Unconstitutionally STOLEN from him by Kamabla, Barrack HUSSEIN Obama, Crazy Nancy Pelosi, Shifty Adam Schiff, Cryin' Chuck Schumer, and others on the Lunatic Left,

CRASHES the Democrat National Convention and tries to take back the Nomination, beginning with challenging me to another DEBATE." "He feels that he made a historically tragic mistake by handing over the U.S. Presidency, a COUP, to the people in the World he most hates, and he wants it back, NOW!!!" UKRAINIAN AIR FORCE THWARTS RUSSIAN DRONE ASSAULT THREE TEHRAN

Ukraine's air force reported the successful interception of 30 drones launched by Russia. The operation was conducted overnight, spanning seven regions. The statement was released on the Telegram messaging app, affirming the air force's effectiveness in countering aerial threats. This victory underscores Ukraine's resilience and air defense capabilities amid ongoing conflicts. Three drones were destroyed over Dnipropetrovsk region, the governor said. Kirovohrad governor said the attack caused no damage in his region after military reported shooting down one drone. Khmelnytskyi governor also reported no damage, saying the air force shot down 11 targets over his region. Ukrainian military said seven drones were shot down over the southern Odessa region with three more downed in Kherson region and two more in Mykolaiv region.
