**Opinion**

1. We have audited the accompanying standalone quarterly financial results of "Ace Edutrend Limited" ("the Company") for the quarter and the year to date results for the period 1<sup>st</sup> April, 2020 to 31<sup>st</sup> March, 2021 attached herewith, being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").

The Board of Directors are also responsible for overseeing the Company's financial reporting process.

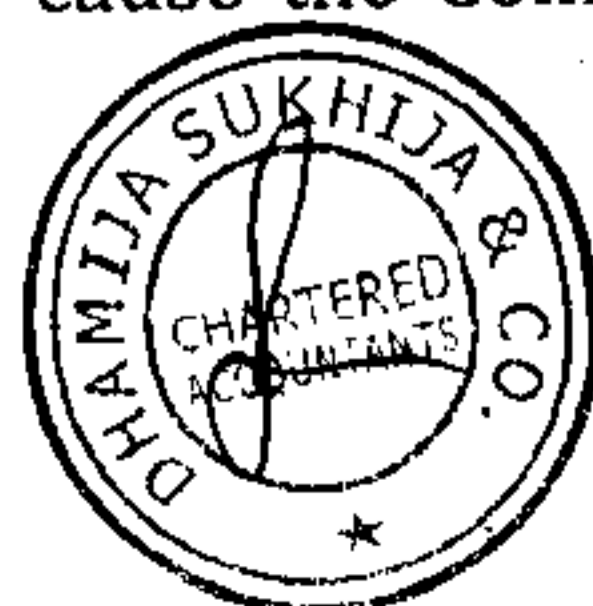


### **Auditor's Responsibilities for the Audit of the Standalone Financial Results**


